

RMHP Medicare Delta Dental Plan Summary

Since 1958, nonprofit Delta Dental of Colorado has provided dental benefits to the people of Colorado. Delta Dental is committed to providing the best possible care to subscribers and their families through community partnerships, varied plan designs, and relationships with dentists. Delta Dental contracts with more than 2,500 Colorado licensed dentists – 85 percent of dentists statewide.

Plan Summary and Benefits

The RMHP plan offered is the Delta Dental PPO Maximum Allowable Charge (MAC) option.

Choose a PPO dentist for the best benefit

- No additional out-of-pocket expenses beyond Member coinsurance
- No billing for services that may exceed PPO allowed fees

Choose a Premier or non-participating dentist

- You will have additional out-of-pocket costs
- You will get billed for services that exceed PPO allowed fees.

If you see a Premier Dentist, you are responsible for the difference between the PPO Dentist's Allowable Fee and the fee from the Premier Maximum Plan Allowance. If you see a non-participating dentist, you are responsible for the difference between the PPO Dentist's Allowable Fee and the full billed charges.

Type I – Preventive Services

- Oral exams, cleanings (2 cleanings + 2 periodontal cleanings per year)
- Fluoride treatment approved for adults with specific conditions
- Plan pays 70 percent
- No deductible

Type II – Basic Services

- All x-rays, simple extractions, pain treatment, and fillings
- Plan pays 50 percent after deductible

Type III – Major Services

- Endodontic Services
- Periodontic Services
- Plan pays 30 percent after deductible

The Terms

- You pay just \$18.00 per Member per month
- \$1,500 benefit maximum per year
- \$50.00 deductible for Basic and Major Services
