### CoverColorado Assessment Fee

Rocky Mountain Health Plans, along with other carriers in Colorado, is required by law to help pay the expenses of the CoverColorado program. The charge for 2010 is \$2.00 per subscriber per month in addition to the health plan premium. The assessment appears on the premium bill as a fee and applies to group and individual health plans. This is a reduction from the 2009 assessment of \$2.40.

### Small Group Amendments

Amendments to the Evidence of Coverage for small groups are being sent to employers. The amendments are necessary due to changes to benefits and other provisions required by recent legislation. Some of the changes are:

#### Preventive Care Services

Updates certain preventive care services and screenings to comply with Colorado House Bill 1204.

#### Eligibility for Children

Provides a 90 day timeframe to enroll in the group health plan after a child loses eligibility on Medicaid or CHP+.

#### Clinical Trials

Clarifies the existing RMHP coverage of covered services obtained as part of a clinical trial to comply with Colorado House Bill 1059.

#### American Recovery and Reinvestment Act of 2009 (ARRA)

Updates the COBRA and CCOC entitlement rights and premium subsidy rights to comply with ARRA and Colorado House Bill 1349.

#### Michelle's Law

A notice in the cover letter describing why it is not necessary for RMHP to change student eligibility status in order to comply with Michelle's Law because the Evidence of Coverage is already compliant.

**RMHP will not mail amendments on these legislative changes to covered employees. Instead, employers are encouraged to direct covered employees to our website, [www.rmhp.org](http://www.rmhp.org), where they can access detailed, up-to-date benefit information at their convenience through access RMHP, our online Member portal.**

We recently sent information regarding access RMHP in our Fall Member newsletter detailing how to register for access RMHP. The following step-by-step instructions were included in that article.

### Member Registration for access RMHP

To register for access RMHP, you need the Member number on your ID card, birth date and email address.

1. Go to [www.rmhp.org](http://www.rmhp.org). In the access RMHP Member section, click the “*Register Now*” button.
2. You will be prompted to accept the online user agreement. When you’re finished, click the button to register for access RMHP.
3. At the sign-in screen, click on the *Members* icon on the lower right of the screen.
4. Enter your Member ID number with suffix (e.g., 000123456 00). **You must have a space before the last 2 digits, not a dash.** Enter your birth date, email address, and select Rocky Mountain Health Plans in the drop down list of Participating Health Plans. Click *Next*.
5. Enter a password – it must be at least 6 characters with letters and at least one number. **Your password is case sensitive.**
6. Enter your Password Reminder Question, Security Question and the Answer. These are used by the Help Desk to validate your identity in the event you forget your password. Click *Next*.
7. Your user ID will be assigned to you. **Be sure to write down your User ID, password and Security reminder questions.** Complete the registration process by clicking the *Finish* button. You can now log in to access RMHP.
