Employer Group Amendments

Amendments to the Evidence of Coverage (EOC) for employer groups are being sent to employers. Changes to the EOC are summarized below.

Mandated Coverage for Autistic Spectrum Disorders *Effective on the group health plan renewal date*

Colorado Senate Bill 09-244 mandates coverage for Autistic Spectrum Disorders for employer group health plans. This benefit will be available for covered employees and family members upon the group's renewal with RMHP. Enrollment of Newborns *Effective July 1, 2010*

All newborn dependent children are automatically enrolled on the covered parent's plan for the first 31 days of life, as required by Colorado law. Effective July 1, RMHP will continue coverage for the newborn unless the subscriber requests the newborn be disenrolled by completing a Change Form and submitting it to RMHP. Any change in premium will be effective the first day of the month following the date of birth.

American Recovery and Reinvestment Act of 2009 (ARRA)

Provisions are added to the EOC to comply with ARRA which was originally passed in February 2009. ARRA provides additional rights to continuation coverage for individuals who have been involuntarily terminated from employment or who have lost coverage due to a reduction in scheduled working hours. ARRA allows certain eligible individuals to pay 35 percent of the COBRA premium during the eligibility period.

Primary Care Physician (PCP) *Effective July 1, 2010*

Effective July 1, the PCP level copay will be applied to services received from the member's designated PCP, as well as from any provider RMHP has designated as a PCP type. The PCP providers designated by RMHP are Family Practice, Internal Medicine, OB/Gyn, and Pediatric physicians.

Notice of Dependent Age Change

Included with the Group Amendment mailing to employers is the RMHP announcement on extending the dependent age limit to age 26, as described in the BBNF dated May 3, 2010.
